

SPECIAL PROGRAM
OF TICKET SALES DURING THE FIRST DAYS OF PRELIMINARY
AT THE STATE ACADEMIC BOLSHOI THEATRE OF RUSSIA

A special program of tickets sales during the first days of preliminary sales has been developed and is being put into effect to ensure the accessibility of theatrical art to different social groups, and, first and foremost, to the spectators who wish to attend the performances personally.

Terms and rules of ticket sales:

1. In accordance with the Preliminary Ticket Sale Schedules, at the Bolshoi Theatre Management Building Box Office on the first day (Saturday) from 10:00 to 20:00 (break from 15:00 to 16:00), and from second till sixth days (Sunday – Thursday) from 11:00 to 20:00 (break from 15:00 to 16:00) (unless other time is specified by the Theatre Administration) tickets are sold on the passport or identity documents of the viewers (passport, birth certificate of a minor child) to prevent the re-purchase; every customer will be entitled to buy a maximum of 2 (two) tickets for the one title.
2. On the first day (Saturday) of the pre-sales from 17:30 tickets are available on the official web-site of the Theatre and are sold via CERTIFICATE; every customer will be entitled to enter personal data and to buy a maximum of 2 (two) tickets in one order. The CERTIFICATE must be printed and exchanged for the original tickets prior to the performance in accordance with Bolshoi Theatre Management Building Box Office opening hours.
3. The customer (the holder of the bank card) must personally exchange the CERTIFICATE for the original tickets by presenting of passport, bank card (used for the transaction) and the documents of the viewers (passport, birth certificate of a minor child). At the time of purchase at the Box Office copies of the documents of the spectators are allowed.
4. On the seventh day of the pre-sales (Friday) from 11:00 tickets are available for purchase at all Box Offices of the Theatre, on the official web-site in accordance with RULES OF TICKET SALES.
5. Tickets sold in accordance with this program are printed on special form with indication of the name and data of the spectator's document (passport, birth certificate of the minor child).
6. Tickets with corrections are invalid. Changes of passport data and the name of the spectator in the purchased tickets are not made.
7. Purchasing tickets in accordance with this program, the customer agrees to the processing of his personal data necessary to establish legal relationship between the Theatre and the Spectator on the purpose of selling tickets, as well as on taking any action with respect to personal data necessary or desired to achieve (including without limitation) collection, systematization, accumulation, storage, clarification (updating, modification), use, distribution (including transfer to third parties), depersonalization, as well as the implementation of any other action with the personal data provided by the current legislation of Russian Federation. The Theater guarantees that the processing of the customer's personal data is carried out in accordance with the Federal Law of 27 July 2006 № 152-FZ "On Personal Data" and other applicable laws of the Russian Federation on the protection of personal data.
8. Attending a performance on the ticket purchased in accordance with this program is carried out on document indicated in the ticket.
9. The Theatre reserves the right to change the terms and rules for ticket sales
